## **INTRODUCTION**

Your privacy is essential to us. Here at Universal Athletic Testing LLC., we believe that privacy is a top priority. We know that you care how information about you is used and shared. Thus, we provide this Privacy Policy to summarize our procedures and practices as it regards to information collection and use. This will serve you as a guide in making an intelligent decision in sharing your information with us. ## **POLICY APPLICATION**

This Privacy Policy applies to the website and all products and services offered by Universal Athletic Testing LLC.. This will describe and explain how we take care and handle the personal information you provide to us. We make every effort to provide a consistent set of privacy practices throughout the marketplace and/or commerce. By accepting the Privacy Policy and the Terms of Use and Conditions Agreement, you expressly consent to our collection, storage, use and disclosure of your personal information as described in this Privacy Policy.

## **INFORMATION COLLECTION AND USE**

You can browse and get onto our websites and applications without disclosing and revealing to us any personal information. Once you provide us your personal information, you are no longer an unknown. You hereby then agree to; us collecting such personal information and allow us to transfer and store all of that information to our server.

We may collect and store the following information:

You understand and agree that we may use your personal information to provide the services and customer support you request; to resolve disputes, collect fees, and troubleshoot problems; to prevent potentially prohibited or illegal activities, and enforce our Terms of Use and Conditions Agreement; to customize, measure and improve our services, content and advertising; to tell you about our services and those of our company, targeted marketing, service updates, and promotional offers based on your communication preferences.

### **DISCLOSURE OF INFORMATION**

We may do so when: (1) permitted or required by law; or, (2) trying to protect against or prevent actual or potential fraud or unauthorized transactions; or, (3) investigating fraud which has already taken place. The information is not provided to these companies for marketing purposes. It should be noted that we don't sell or rent your personal information to third parties for their marketing purposes without your explicit consent.

### **COOKIES**

When you visit our websites and applications, we send one or more cookies (small files placed on your hard drive) to your computer or other device that uniquely identifies your browser. We use cookies to improve the quality of our services, including for storing user preferences, improving search results, ad selection, and tracking user trends such as how people search. We also use cookies for advertising services to help advertisers and publishers serve and manage ads across the web.

### **INFORMATION SECURITY**

We adopt appropriate data collection, storage and processing practices and security measures to protect against unauthorized access, alteration, disclosure or destruction of your personal information, username, password, transaction information and data stored for our websites and applications. We secure your information during transmission by using a system which encrypts information you input. We reveal only a

few digits of your credit card numbers when confirming an order. Of course, we transmit the entire credit card number to the appropriate credit card company during order processing. It is important for you to protect against unauthorized access to your password and to your computer. Your information is stored on our server and we use systems to protect such information.

All collected information is stored in a technically and physically secure environment. While we use SSL encryption to protect sensitive information online, we also do everything in our power to protect PII (including Sensitive Information) off-line.
